Review/Approval of Agenda

Recommendation for new hire: April Cuykendall, LRE Aide

-Mr. Shaw reported that Interviews had been conducted and April Cuykendall is being recommended for approval, at a rate of pay of \$10.86 per hour.

Recommendation of School Finance Research Collaborative Resolution

-Mr. Shaw reported that the Board is being asked to support the research in proper funding of public schools in the state. By passing the resolution the Board of Education is asking the State to use the Adequacy Study from 2016 work on funding Public Education appropriately.

Recommendation to approve overnight conference for Kelly Trainor, MIAAA Athletic Administrators Annual Conference, March 15-19, 2018, Traverse City, MI

-Mr. Shaw presented that Ms. Trainor is requesting to attend the MIAAA Athletic Administrators Annual Conference in Traverse City, MI. The approximate cost is \$1,089.53 paid by general fund.

Recommendation of Policy 6320 – Purchasing revision

-Mr. Shaw presented that by changing Board of Education meetings and no longer having Finance / Facilities Committee the Purchasing policy needed to be changed. One new item that we will be added is the Competitive Bid Threshold for each Fiscal Year, for FY 2018 the threshold is \$23,881.

Mason / Whiteford Cooperative Agreement for Business Services

-There was conversation regarding the Cooperative Agreement with Whiteford. The discussion focused on the following: is the cooperative agreement the right thing for Mason at this time, what the potential is for the two Districts to find a finance director should something happen to the current director, what the office would look like if we did not share a finance director and how human resources fits into the picture. Mr. Shaw reported that the contract is up in June 2019. Through discussion nothing will change and that we will come back in the fall and revisit the cooperative agreement.

Public Comment

Jennifer Mishka thanked Mr. Shaw and the Board for their support of the VFW. She reported that Michael Moss won the local Voice of Democracy contest and also placed third at the district level. Hanna LaVanway also qualified for district and took second place. She reported on the amount of participation of the middle and high students. The dates were switched for recognizing teacher of the year so this recognition will not be done this year. It will continue next year. The Patriot's Art just started. The Board is invited to the Recognition Dinner at the VFW on March 24, 2018.

Grace Connolly commented on the handicap parking spot out front.

Superintendent's Report

We have been working with the ISD and MASSP to bring Restorative Justice Training to our County. We are working on a date for February. The training is two days. During the evening of the first day there will be a session for Boards of Education to attend.
