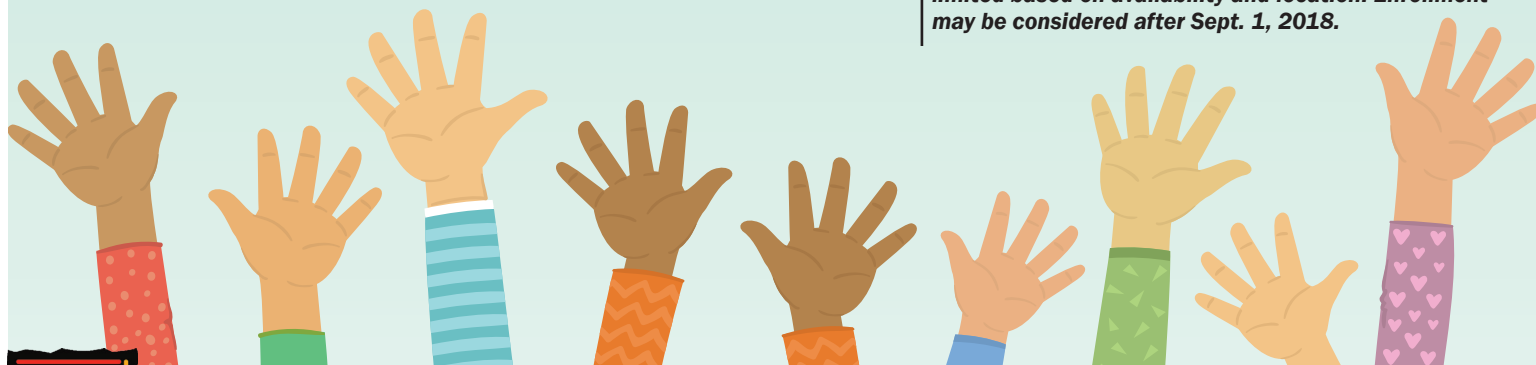

APPLICATION CHECKLIST TO COMPLETE YOUR CHILD'S APPLICATION, YOU WILL NEED TO BRING THE FOLLOWING

(Please check off items when complete)

- Proof of Income
 - 2017 W-2s
 - Income Tax Return
 - SSI, TANF
 - 4 weeks of pay stubs
- Foster Care documentation if applicable
- Child's Birth Certificate
- Immunization Record (if available)
- Proof of Residency (drivers license, bill, rent lease, etc.)

***SB 133 allows children turning 4 between Sept. 2, 2018 - Dec. 1, 2018 to submit a waiver application. Space is limited based on availability and location. Enrollment may be considered after Sept. 1, 2018.**
